SCOPE OF WORKS FOR CUNNINGHAM TRANSMISSION LINE RE-SURVEY

Re-survey of the Cunningham substation lease, to demarcate its original boundaries and identify squatters illegally encroaching into FEA lease.

FEA has a registered lease over the subject property on NL 17640 on records with TLTB under their reference 4/3/3138.

Under the current registered lease, the lease area noted is 7 acres, 1 rood and 15 perches under lot 4 R 2064 on iTaukei land known as Nivoco (Part Of). The subject property comprises of the Zone Substation and switchyard.

The Scope of Work is as follows:

- 1) Site Inspections
- 2) Information search
- 3) Application for Survey Instructions to the I-Taukei Land Trust Board.
- 4) Re-definition of the subject property boundaries and identification dwellings encroaching within FEA Lease.
- 5) Lodge necessary reports, plans to FEA and obtain the consents of the Director of Town and Country Planning and the Secretary, Suva City Council **"if necessary"**.
- 6) Carry out the field survey in accordance with the I-Taukei Land Trust Boards Survey Instructions
- 7) Installations of Boundary pegs and line pegs.
- 8) Carry out final inspections with FEA lands officers for the identification of boundary pegs.

Disbursements will be made for all necessary statutory fees paid on behalf of the Fiji Electricity Authority. Official receipts are to be provided when claiming for such disbursements.
