Scope of Supply – New Diesel Fire Pump for Vuda Power Station

Fiji Electricity Authority invites potential bidders to bid for the supply, installation and commissioning of a new diesel fire pump at FEA's Vuda Power Station. A fire pump with diesel engine unit complete with base frame and all required accessories is to be supplied. The pump is to be connected to the existing fire sprinkler system at Vuda Power station.

Supply Specifications:

- a. Diesel engine fire pump conforming to NZS4541 requirements for fire sprinkler pump is to be supplied, inclusive of glands, inlet and outlet flanges matching existing flanges onsite.
- b. Suitable diesel engine for the fire pump Engine shall be supplied with all standard accessories such as governor, flywheel with housing, vibration dampers, industrial grade silencers etc.
- c. Automatic control panels with instruments mounted therein including tubing, wiring, terminal boxes, breakers and all required accessories.
- d. All other required accessories and spares including foundation bolts and nuts, leveling base screws etc. for commissioning purposes and also for the successful running of the pump.
- e. A set of shim plates as required for normal alignment
- f. Fire pump recommended spares.

Note:

- 1. The quoted rates for pumps shall include commissioning spares required for commissioning of the pumps on site.
- 2. Bidder shall furnish along with the technical bid all the list of commissioning spares.
- 3. Bidder shall also furnish details of special tools required for installation and commissioning
- 4. Site inspection is mandatory!
