<u>Scope of Work – Maintenance of Fuel Supply Line, Tank and Tank Base at Rokobili Power</u> Station

Fiji Electricity Authority invites potential bidders to bid for the maintenance and rust management for the fuel supply line at Rokobili Power Station.

The fuel supply line, its braces and the steps providing access to the Industrial Diesel Oil (IDO) needs mending and a double coat finishing to be applied.

Scope Details

The contractor shall accomplish all work to carry out rust management and double coat finishing of the amenities which includes the fuel line, its braces and steps for the Rokobili Power Station Industrial Diesel Oil (IDO) storage tank.


- 1. The contractor shall carry out rust management to eliminate all the existing rust on the fuel line. The braces of this fuel pipe line and the steps to access the IDO fuel tank shall also be treated.
- 2. The contractor shall apply rust guards on all the pipes including the fuel line, its braces and the steps to access IDO storage tank.
- 3. The contractor shall apply double coat finishing on all the amenities stated to provide additional durability. This shall be according to FEA colour code.

Note:


- The bidder shall provide information in the similar types of works.
- The quotes shall include materials and furnish details of special tools/equipment required for maintenance of the fuel supply line, tank and tank base.
- All materials and consumables must be self-supplied and materials not supplied must be clearly stated.
- All removed materials to be left at Rokobili Power Station.
- Site inspection is mandatory!


