Section 1. Instructions to Bidders

1. Scope of Bid	The Fiji Electricity Authority (hereinafter referred to as "the Employer", wishes to receive bids for CARTAGE OF CULVERTS FROM FEA KINOYA DEPOT TO TOWER ACCESS ROADS SITES NEAR KORO VILLAGE AND NADRUGU VILLAGE as specified in these bidding documents.		
	preferred supplier for a minimum period of 12 Months.		
2. Eligible Bidders	This Invitation to Bid is open to bidders who have sound financial background and have previous experience in this area.		
	Bidders shall provide such evidence of their continued eligibility satisfactory to the Employer as the Employer shall reasonably request.		
3. Cost of Bidding	The bidder shall bear all costs associated with the preparation and submission of its bid and the Employer will in no case be responsible or liable for those costs.		
4. Deadline for Submission of	Bids must be received by the Employer at the address specified above no later than 4pm on Wednesday, 27th September 2017.		
Bids	The Employer may, at its discretion, extend the deadline for submission of bids by issuing an addendum, in which case all rights and obligations of the Employer and the bidders previously subject to the original deadline will thereafter be subject to the deadlines extended.		
5. Late Bids	Any bid received by the Employer after the deadline for submission of bids will be rejected and returned unopened to the bidder.		
6. Employer's Right to Accept any Bid and to Reject any or all Bids	The Employer reserves the right to accept or reject any bid, and to annul the bidding process and reject all bids, at any time prior to award of Contract, without thereby incurring any liability to the affected bidder or bidders or any obligation to inform the affected bidder or bidders of the grounds for the Employer's action.		
10. Notification of Award	Prior to expiration of the period of bid validity prescribed by the Employer, the Employer will notify the successful bidder through an official award letter.		
	The notification of award will constitute the formation of the Contract.		
11. Signing of Contract Agreement	At the same time that he notifies the successful bidder that its bid has been accepted, the Employer will send the bidder the Form of Contract Agreement provided in the bidding documents, incorporating all agreements between the parties.		

Within 7 days of the receipt of the Form of Agreement, the successful bidder shall sign the form and return it to the Employer.

- 12. CorruptorThe Employer requires that the Contractor observe the highest standard of ethics
during the procurement and execution of such contracts. In Pursuance of this
policy, the Employer:
 - (a) defines, for the purposes of this provision, the terms set forth below as follows:
 - (i) "corrupt practice" means behavior on the part of officials in the public or private sectors by which they improperly and unlawfully enrich themselves and/or those close to them, or induce others to do so, by misusing the position in which they are placed, and it includes the offering, giving, receiving or soliciting of anything of value to influence the action of any such official in the procurement process or in contract execution; and
 - (ii) "fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of the Employer, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the Employer of the benefits of free and open competition;
 - (b) will reject a proposal for award if it determines that the bidder recommended for award has engaged in corrupt or fraudulent practices in competing for the contract in question;

Technical Specifications of the Truck

1. General Description

The supplier is to transport the culverts for the Fiji Electricity Authority from its Kinoya Depot to the following locations:

 a. FEA 132kV Tower Access Road Entrance off Koronubu/Bukuya road near Nadrugu Village. (246km from Kinoya Depot via Kings Road to Ba Town and Up Koronubu / Bukuta Road from near Rarawai Mill)

b. FEA 132kV Tower Access Road Entrance near Koro Village. (223km from Kinoya Depot via Kings road to Koro Village)

FEA is also looking to award this tender for preferred suppliers for a period of 2 years to cart culverts on a rate to measure payment basis on per ton per km rates for combination of culverts types to be transported as per their unit weights. The culverts shall be used for the purpose of construction of the Access roads to its 132kV Transmission lines in both Central and Western regions.

3. OHS Certification

The trucks shall be OHS Certified. It is mandatory for this certificate to be provided with the Tdner Bid. All the accessories (such as belts, chains etc.) shall be provided by the supplier and have been inspected to comply with OHS certification. Necessary documentation shall be submitted as evidence by the bidder to ensure compliance.

4. GENERAL REQUIREMENTS

The following details are also to be submitted with the tender bid:

- a. Truck Driver details (Name, FNPF NUMBER, Years of employment, years of experience etc.)
- b. PPE details of the driver
- c. License details of the driver (ID card copy to be provided)
- d. Truck Wheel Tax expiry details
