##### **1.2 Transportation of Materials**

The materials listed above is to be transported from Fiji Electricity Authority Depot Cawaira, Labasa to Fiji Electricity Authority Depot Somosomo, Taveuni. **Loading** of Materials at FEA Depot Cawaira, Labasa and **Unloading** of Materials at FEA Depot Somosomo, Taveuni will be done by the Bidder. The bidder is to provide 4x4 Hardwood Spacers which will be used in-between Concrete Poles while being Transported and also for Stock piling at Fiji Electricity Authority Depot Somosomo, Taveuni.

Note. Any Damage to the Materials during Loading/Unloading and Transportation, the bidder will be held liable for Replacement/Cost of the material.

#### **2.0 PRICES AND QUALITY REQUIRED**

Prices shall be quoted in Fijian Dollar Currency (FJD), inclusive of all taxes, customs, clearance charges, and duties payable in Fiji.

### 3.0 INSURANCE

The bidders are required to submit the following documents in the tender document which are stated below:

#### 3.1 Vehicle 3<sup>rd</sup> Party Insurance

Third Party Car Insurance covers damages which may be caused to other people's vehicles and property only by the Bidder.

#### 3.2 Vehicle Insurance

Vehicle insurance is insurance for trucks or Cranes and other road vehicles. This Document will provide financial protection against physical damage or bodily injury resulting from traffic collisions.

#### 3.3 Workers Compensation Insurance

Workers compensation Insurance covers lost wages and medical treatment resulting from an employee's work-related injury or illness. It also covers services needed to help an employee recover and return to work.

#### 3.4 Public Liability

Public liability is part of the law of tort which focuses on civil wrongs.

#### 3.5 Marine Insurance Cover of \$100,000 Value

Marine insurance covers the loss or damage of ships, cargo, terminals, and any transport or cargo by which property is transferred, acquired, or held between the points of origin and final destination. Fiji Electricity Authority requires the bidder to submit a Marine Insurance Cover of a Value of One Hundred Thousand (\$100,000).
